WINNER RELEASE, ACKNOWLEDGEMENT AND AUTHORIZATION

I recognize that there are certain inherent risks associated with the activity described herein, and I assume full responsibility. I hereby authorize the release of my name, street address, and telephone number to Atlas Experiences, LLC (“Prize Provider”) and third parties, as necessary, for prize fulfillment of the **Hawaii VIP Getaway Trip** (“Trip” or “Prize Package”). I understand, I, my guest, any Proxy I may appoint, and their guest, as applicable, will be required to sign a release provided by the Atlas Experiences, LLC.
