I acknowledge and agree that the Certificate constitutes the entire prize. Any amenities, upgrades, travel, off-ship excursions, on-board costs and expenses, rebooking and cancellation fees, and any other costs or fees are my sole responsibility.

I understand and agree that the Certificate permits two (2) people to take a cruise with Royal Caribbean. My guest must be at least six (6) months of age. Should I choose to allow someone else to use the Certificate, I may give the Certificate to another person. This will not reduce my tax liability with respect to the Prize. The Certificate must be given in full; no portion of the Certificate, or element thereof, can be retained by me, except for allowing a guest to accompany me.

I understand and acknowledge that the cruise must be booked and completed on or before June 9, 2023 to receive the full value under the Certificate. Bookings are subject to availability. If a cruise is not completed by June 9, 2023, the Certificate will be given a dollar value based on the value of the Certificate as specified by Royal Caribbean in its annual pricing grid for Certificates in effect at the time of purchase. That value may be applied to a future cruise. If the new value does not cover the cost of a future cruise, I am solely responsible for any additional cost and expense. I understand and acknowledge that no exchanges, substitutions, or cash redemption can be made. Any reduction in the Certificate's value will not reduce the value of the Prize for tax purposes.

I understand and acknowledge that a lost, mutilated, or stolen Certificate will not be replaced and may not reduce the value of the Prize Package for tax purposes.

Any litigation arising shall be brought in either Leon County, Florida or the North Florida District of the appropriate State or Federal court. Florida state law shall apply.

I further understand and acknowledge that upon receipt of the Certificate that the Florida Lottery shall have no further obligation, responsibility, or liability with respect to this Prize. This Release also binds my guest and/or any person to whom you give the Certificate.
