RELEASE, ACKNOWLEDGEMENT AND AUTHORIZATION

I recognize that there are certain inherent risks associated with the activity described herein, and I assume full responsibility. I further understand and acknowledge that the Florida Lottery has no control over the providers of any aspect/element of the Trip Prize. In consideration of, and effective upon the date of award to me of a second prize of a trip ("Trip Prize") in the **Truck, Bucks and Trips Promotion** and other good and valuable consideration, I release and forever discharge the Florida Lottery, its employees, agents, affiliates, their successors and assigns, personal representative, and heirs from any and all claims, causes of action, demands, losses and liabilities, of any nature whatsoever, which I may be entitled to assert, including but not limited to, claims for injury, death, illness, or financial losses arising out of the award, receipt or use of said prize.

I hereby authorize the release of my name, street address, email address, and telephone number to third parties as necessary for prize fulfillment of my Trip Prize.

I understand that I must book my Trip Prize by the booking deadline of April 29, 2022 and take the trip by December 31, 2022. I further understand that if I do not book my trip prior to the booking deadline, I will forfeit the second prize, except for the gift cards, and I will remain taxable on the entire value of the Trip.

I understand that myself or my guest must be 21 years of age to check in to the hotel. I understand that I will be required to submit a valid major credit card to the hotel to cover all expenses not specifically awarded as part of the trip.

I understand that myself or my guest must be 25 years of age to rent a car without incurring additional fees and that renters under the age of 25 will be subject to additional international driving fees which are not included in the prize; and that I would be responsible for such additional fees. I understand that I will be responsible for the cost of any insurance on the rental vehicle.

I understand that any minor traveling with me must be accompanied by an adult on the fishing trip.

I understand that I may appoint a proxy to take the trip in my stead provided there is sufficient time to adjust the travel arrangements. I further understand that if the proxy does not book the trip prior to the booking deadline, I will forfeit the trip portion of the prize. I understand and agree that this is a complete RELEASE and DISCHARGE of all claims and rights I may have against the Florida Lottery and that no action will be taken by me, or on my behalf, with respect to any such claims or rights, it being understood that the release shall be binding upon my heirs, executors, or administrators.

Any litigation arising shall be brought in either Leon County, Florida or the North Florida District of the appropriate State or Federal court. Florida state law shall apply.
